The City Honors mock trial team completed another excellent season, finishing 3-1 with victories over Sacred Heart, Williamsville North and St. Joe's. The close playoff loss was against Orchard Park, who got their revenge after we beat them last year.

This year's team included seven new competitors. Maggie Giancola and Daniel Moka competed as attorneys, both improving by leaps and bounds from their first practices into the playoff rounds. Kasity Peffer, Ava Azizoghli, Issrat Prova, and Ayeeza Modassar all played witnesses for the first time. The case involved a construction accident, and all of them needed to be knowledgeable about construction safety. They embraced complex personalities of the characters and the technical aspects of the claims and defenses. Christian Bagby covered both attorney and witness roles in practice as an alternate, and with a year under his belt, will hopefully return next year along with the rest of the new team members.

Returning from last years' championship team was senior Liam Rio, who played the injured plaintiff this year, his third character in as many years. Liam will graduate as one of the finest witnesses

we've ever had. Annika Wilewicz and Nathan Lloyd each made huge strides as returning attorneys, becoming more polished and persuasive in their questioning and arguments. They will hopefully lead the team next year and be even more spectacular once they get to compete live in a courtroom. Senior Liam Cobb made a sensational transition from witness last year to closing attorney this year, embracing the larger assignment and attacking objections and rules

of evidence like a seasoned veteran. The most valuable team member however was senior Ciah Courtney, a four-year veteran of the team who both excelled individually and assisted all of her teammates.

Our students learned valuable skills in presenting arguments, advocating for one side and reacting to opposing views. We look forward to another successful run next year!
